July 1st, 2014 Ridgebury Township Supervisors' Meeting Minutes

Supervisor Gee called the meeting to order at 7:00pm. The meeting was held at the Ridgebury Township Municipal Building, located at 13278 Berwick Turnpike, Gillett, PA. The meeting began with the township supervisors leading those present in the pledge of allegiance.

Announcement of recording: Township

Board of Supervisors present: Gary Gee, Kevin Yaggie, and Percy Talada

Supervisor Talada motioned to approve the minutes from the June 3rd meeting, seconded by Supervisor Yaggie, motion carried.

Public Participation:

Dave Baker: Commented that Park Day was well done this year.

Terry Husted: Gave the supervisors pictures of the ladder in the shed out back and expressed concern over its safety.

Opening of Fuel Bids:

Bid for a one year contract with a start date of August 1, 2014 and end date of July 31st, 2015 for ultra-low sulfur diesel fuel and 86 Oct NL gas to be delivered to the Township garage as needed during the year.

A total of 2 bids were received:

- Welles Mill Co Inc- B2 Clear ULSD \$3.13/gallon unleaded gasoline- \$3.01/gallon
- Williams Oil Company Inc.- ULSD \$3.34/gallon- unleaded gasoline- \$3.24/gallon

Supervisor Talada motioned to accept the fuel bid from Welles Mill Co Inc. at a price of \$3.13/gallon for diesel fuel and \$ 3.01/gallon for unleaded gasoline, seconded by Supervisor Yaggie, motion carried.

Supervisor Gee motioned to pursue paving Colwell Road from the bridge to Centerville Road, seconded by Supervisor Yaggie, motion carried.

Supervisor Yaggie motioned to rent equipment to clean ditches, pending Greg Dibble's recommendation, seconded by Supervisor Talada, motion carried.
