Deb Grumbach: Questioned if any road surface material is going to be added to Gee Road this year.

Judy Walsh: Questioned the \$42,272.66 transfer into the Liquid Fuels account from the Impact Fee Account on last month's treasurer's report. Mrs. Walsh also had questions in regards to the federal tax withholding for her tax commission paychecks.

Leland Stringham: Questioned if there are any plans for repairs on May Hill Road this year. Mr. Stringham also questioned the trees in the creek by the old dump on Monkey Run Road.

David Baker: Concern about the heavy truck and bus traffic on May Hill Road and making sure that it is repaired to withstand this traffic.
