Board of Supervisors present: Gary Gee, Kevin Yaggie, and Percy Talada

Public Participation:

Leland Stringham: Questioned if the blacktop on Gee Road is going to be fixed.

Dave Baker: Question about his driveway and the recent work done to the ditches. Mr. Baker stated that he thinks the supervisors should appoint a Road master so that residents have someone to discuss their concerns about the roads with.

Supervisor Talada motioned to accept the minutes from the August 5th meeting, seconded by Supervisor Yaggie, motion carried.

Correspondence and Communications:

Correspondence from Endless Mountains Visitors Bureau was reviewed. The Board of Supervisors will hold a special meeting with the County Commissioners and Endless Mountains Visitors Bureau within the next 2 weeks, to discuss the Commissioners proposed tourism plans.

Correspondence from PSAT's Trustees Insurance was reviewed with a proposed resolution. Solicitor Thompson will research this before any action is taken.

Old Business:

Supervisor Yaggie motioned to authorize Solicitor Thompson to advertise the CPA Ordinance, seconded by Supervisor Talada, motion carried.

Supervisor Yaggie motioned to authorize Solicitor Thompson to advertise the Floodplain Ordinance, seconded by Supervisor Talada, motion carried.

Supervisor Talada motioned to purchase a portable, welder/generator from Quality Welding, using funds from the Equipment Fund, if possible, seconded by Supervisor Yaggie, motion carried.

New Business:

Discussion about passing a resolution to remove trees in the Township Right of Way. The secretary will check into this.

Perry Sub-division: Supervisor Talada motioned to accept the sub-division as submitted and to authorize the secretary to sign the acceptance letter, seconded by Supervisor Yaggie, motion carried.

Supervisor Yaggie motioned to accept the Floodplain Management Agreement with Code Inspections, seconded by Supervisor Talada, motion carried.
