Supervisor Talada motioned to accept the minutes from the November meeting and the Budget meetings, seconded by Supervisor Yaggie, motion carried.

Financial Reports:

Supervisor Yaggie motioned to ratify the funds used to pay bills and make purchases as listed on the check detail reports, seconded by Supervisor Talada, motion carried.

Supervisor Gee motioned to accept the Treasurer's Report, as given, seconded by Supervisor Talada, motion carried.

Road Crew report and Code Inspections were reviewed.

Supervisor Yaggie motioned to waive the probation period for Kevin Chapman be waived, seconded by Supervisor Talada, motion carried.

Supervisor Yaggie motioned to lock in Costars price for JD672, purchasing from Five Star, using funds from the Equipment Fund, Impact Fee, and a possible loan, seconded by Supervisor Talada, motion carried.

New Business:

Supervisor Yaggie motioned to authorize Solicitor Thompson to communicate with DCED for loan approval and to prepare small borrowing documents and borrowing base certificate, seconded by Supervisor Talada, motion carried.

The 2015 Proposed Budget is available for inspection and will be voted on at the Year End Meeting on December 30th.

Supervisor Yaggie motioned to approve Resolution 2014-04, increasing the Fire Tax by half a mil for tax year 2015, seconded by Supervisor Talada, motion carried.

Supervisor Yaggie motioned to accept Resolution 2014-05, suspending Occupational and Per Capita taxes for 2015, seconded by Supervisor Talada, motion carried.

The Auditors' Organizational Meeting will be held on January 6, 2015.

Supervisor Gee adjourned the meeting at 7:27pm.
