**Leland Stringham:** Questioned how much was budgeted for tar and chip and if any new roads are going to be done this year. Mr. Stringham also questioned the interest rate for the grader loan and asked why the supervisors don't use the CD's instead of taking out a loan. Discussion followed.

Supervisor Yaggie motioned to advertise for bid 5,000 ton of 2RC or DSA, road topping to be tail-gated or stockpiled, seconded by Supervisor Talada, motion carried.

Supervisor Gee adjourned the meeting and announced that an Executive Session would be held to discuss possible litigation with no action being taken.
